All contractors who plan to work on laying drains / water services from existing public sewers and water mains to the building drain of homes, commercial buildings, industrial buildings, and similar structures and properties must be current with the Town of Plainville.

Applicants must provide (along with application):

Valid HEO License

Insurance Certificate (Town must be listed as additionally insured) Performance Bond (\$15,000)

Three Reference (Not Required for Renewals)

License Fee of \$150

All Drainlayers and Water Installers must understand and adhere to the Water and Sewer Regulations of the Town of Plainville. Prior to backfilling work must be inspected by Town of Plainville Operational Staff. 72 hours' notice is required to inspections and mark outs.
